DESCRIPTION OF BUILDING PRODUCT

Brad nails (brads) have a small head and fine gauge and are intended to be used where less obvious fixings are required such as installing skirtings, decorative linings, or in joinery where less holding power is required than other fixings options (such as screws).

Building King brads are supplied in either electro-galvanised or 316 stainless steel. They are available in various sizes from 32mm to 63mm and either straight or angled 20°.

All Building King brads are supplied so that they may be installed with brad guns.

Staples are supplied to hold building paper and other building material whilst other more permanent fixing is applied (such as battens). Staples are made of electro galvanised steel or 316 stainless steel and supplied in a variety of lengths.
